



Charity Retail Conference 2024: Ten Bursary Places

The Charity Retail Conference, held at Harrogate Convention Centre on Wednesday 26 – Thursday 27 June 2024 is a fantastic opportunity for delegates to update their knowledge, network with colleagues and **learn more** about the issues facing charity retail. The conference offers you interactive focus sessions, an exhibition, drinks reception, awards dinner, and lots of opportunities to network with people within the sector.

- Bursaries are available to those who work in charity retail
- Your charity must run five or fewer charity shops
- This is the first year you personally are attending the conference
- Only one delegate per charity may apply
- Both members and non-members of the CRA may apply

The deadline for applications is Friday 17 May 2024. Winners will be notified by Friday 24 May 2024.

Full Terms & Conditions

- Bursaries are available to those who work in charity retail
- Only representatives of charities running five or fewer charity shops as of 1 April 2024 are eligible to apply
- This must be the first year **you** are attending the conference
- Only **one** delegate per charity may apply
- Both members and non-members may apply
- The bursary covers half the delegate fee at the conference for a 2-day delegate ticket, including session attendance, all meals and refreshments, the awards drinks reception and dinner accommodation is not included
- Bursary winners are required to pay 50% towards their place. Payment must be received by
 Friday 21 June 2024 or you may forfeit your place
- The bursary **does not** cover any related costs of attending the conference, e.g. travel
- Any application received after the closing date on Friday 17 May 2024 will not be considered
- Each application will be assessed individually by the Charity Retail Association whose decision will be final
- If you are a successful bursary applicant but have already paid the full delegate fee, the Association will refund half your delegate fee
- Bursary recipients will be notified by Friday 24 May 2024
- By signing the Bursary application form you agree to have a photograph taken with the sponsor at the conference which will be used by the sponsor and the Association for marketing and promotional purposes. Photographs will be taken at the conference at a time to be confirmed with the bursary sponsor.
